ULAKNET USE POLICY

ARTICLE 1. PURPOSE

This usage policy; An institute of the Scientific and Technological Research Council of Turkey (TUBITAK) The National Academic Network operated by the National Academic Network and Information Center (ULAKBİM) (ULAKNET) regulates the procedures and principles regarding its use.

ARTICLE 2. SCOPE

This usage policy; It covers all organizations and users who use ULAKNET.

ARTICLE 3. DEFINITIONS

In this usage policy;

ULAKBİM; National Academic Network and Information Office of the Scientific and Technological Research Council of Turkey

is the Center.

ULAKNET; Assignment in the "Law on the Establishment of TÜBİTAK" dated 17/07/1963 and numbered 278 within the framework of education and training, in accordance with the laws of the Republic of Turkey and TUBITAK legislation.

electronic communication service and/or electronic communication infrastructure of research institutions It is the National Academic Network whose requirements are met.

ULAKNET Usage Policy (UKP); This is the ULAKNET Usage Policy.

Sub-Policies; The principles and principles of use of the services provided by ULAKBIM through ULAKNET. are additional policies established to determine

User Organization; Connecting to ULAKNET by signing the UKP; higher education institutions, TUBITAK units, public and private research institutions and applications are accepted by the ULAKBİM Board of Directors. established organisations.

Users; Students authorized by the User Organization to use the infrastructure and resources of the institution, faculty members, researchers and/or other members. Although the User is not a member of the Organization, Authentication and authorization when accessing corporate network resources and while remaining connected to the network. Temporary/guest users that can be made are also in this group.

Signatory Party; Person in charge of the organization's top management, signing the UKP on behalf of the User Organization

or authority. This authority is the rector in universities or the rector authorized by the rector.

Assistant General Manager, Head of Institution, Institute/Unit Manager or equivalent in other institutions.

ULAKNET End Management System (*UUYS*); The information belonging to the User Organization is kept and with ULAKBİM.

It is a web-based system used to accelerate the communication between the User Organization.

NMS Administrator; Responsible for the actions taken on the NMS of the Signatory Party the person appointed/authorized.

TUBITAK EKUAL; some text and bibliographic databases, academic and research

Initiated by ULAKBIM in 2006 to make it accessible to institutions

It is the service with the "Electronic Resources National Academic License".

TRUBA: High-performance, grid, cloud and similar computing systems and scientific data warehouses

According to the ULAKNET Event Log Sub-Policy, the information is reported to the network administrators of the User Organization.

It is the Incident Tracking Service that is followed.

ULAKNET Network Operation Center (NOC): Working within the ULAKBİM Network Technologies Unit and It is the unit responsible for the technical management of ULAKNET.

ULAKNET Communication Lists; "ulak-y@ulakbim.gov.tr" established by ULAKBİM and "ulak-

Teknik@ulakbim.gov.tr" are electronic communication groups with Internet addresses.

Unwanted Traffic; It will affect, disrupt and create confusion on the service quality on ULAKNET. or network traffic that will not allow others to use it on ULAKNET.

ARTICLE 4. GENERAL PROVISIONS

4.1. ULAKNET is used in accordance with the laws and regulations of the Republic of Turkey. User

The Organization, its Users, ULAKNET in accordance with the laws of the Republic of Turkey and relevant legislation. use is at your own risk.

4.2. ULAKNET, education, training, scientific and technological research and development, scientific, technological and should be used for the purposes of dissemination or access to cultural knowledge. User Organization, ULAKNET cannot use it directly or indirectly for commercial purposes, cannot be used in exchange for income.

- **4.3.** ULAKNET, within the scope specified in articles 4.1 and 4.2 and drawn in the UKP and related Sub-Policies managed and used within the administrative and technical framework.
- **4.4.** The User Organization makes the necessary technical and administrative arrangements and provides adequate employs a large number of technical personnel.
- **4.5.** The User Organization creates its own usage policy for its Users in accordance with the UKP is expected. User Organization's usage policies and User Organization or Users' "Legal Disclaimer" texts cannot invalidate part or all of the UKP.
- **4.6.** User Organization, to use the new services offered through ULAKNET and contributes to its dissemination. For this purpose, dissemination of new services ULAKBİM

can be encouraged by

4.7. For efficient and safe use of ULAKNET; User Organization, Unwanted Traffic of Users It should prevent the creation of a system and provide adequate system and network security. User Organization, Without the approval of ULAKBİM, third parties or organizations other than its Users may submit to ULAKNET. cannot gain access.

4.8. Any of the provisions of the UKP may be valid by ULAKBİM. and/or technical reasons, temporarily or indefinitely, the remainder of does not affect its validity and continuity.

ARTICLE 5. RIGHTS, AUTHORITIES, RESPONSIBILITIES and PRACTICES

- **5.1.** The User Organization provides ULAKNET to its Users within the framework of the provisions determined by the UKP. has the right and responsibility to use it.
- **5.2.** User Organizations with a global Internet connection other than ULAKNET,

ULAKNET is the part of the traffic belonging to the services from the User Organization towards the Internet. they have to direct.

- **5.3.** ULAKNET connection to TÜBİTAK EKUAL services of the User Organization in the direction of outbound and return access is required.
- **5.4** . The User Organization provides the necessary support for its researchers to benefit from TRUBA services. User Organization, incorporation of compute and storage resources in its campuses into TRUBA

in the event of a failure, to ensure coordination between their units so that TRUBA services are not disrupted. and take adequate security measures.

5.5. The User Organization submits the requested information on the OLTA System in a timely, accurate and complete manner.

It is responsible for entering and taking the necessary measures to close the event records.

5.6. The User Organization provides the requested information in a timely, accurate and complete manner through UUYS. Responsible for ensuring that the entered information is up-to-date. Signatory, NBS Administrator reports its information to ULAKBİM in the annex of the UKP. In case the NMS Administrator changes, the Signer The party notifies ULAKBİM with an official letter of the new NUSS Manager information. In this context, the authorized

It arises due to the activities of the administrator or any person who is not authorized to access the system.

The User Organization is responsible for the consequences that may occur.

5.7. The User Organization is obliged to cooperate with ULAKBİM for the operation of ULAKNET. According to this;

a) ULAKNET Communications, of which the User Organization, administrative and technical responsibles are members By following the lists, providing the information requested by ULAKBİM accurately and on time,

Line failures announced by ULAKBİM, maintenance works that will cause interruptions

It is responsible for informing its Users about it as soon as possible.

b) User Organization, ULAKNET administrative and technical officers organized by ULAKBİM.

It should encourage participation in workshops, trainings and meetings where it meets.

c) All kinds of problems and malfunction notifications regarding ULAKNET are made through NOC and by the User Organization.

ARTICLE 6. TERMINATION OF SERVICE, EXECUTION AND ENFORCEMENT

6.1. If ULAKBİM determines that the UKP or its Sub-Policies are not complied with, the User

It has the right to terminate some or all of the services it provides to the organization. According to this;

a) The User Organization violates the UKP and is warned in writing by ULAKBİM.

If it cannot make up for it within ten (10) days from the date of departure, ULAKNET access is terminated. All violating This situation continues until the conditions disappear. In case of repetition of the violation for the same reason, The User Organization is disconnected without written warning.

- b) The cases of non-compliance with the Sub-Policies and the sanctions to be applied are determined by the Sub-Policies.
- **6.2.** The User Organization considers ULAKBİM's legal and technological changes in the UKP.

He knows he can change. The changed usage policy is on the ULAKBIM website.

It enters into force on the date it is signed by the organization and delivered to ULAKBİM. New policy comes into effect

If it is not signed within 3 months, the old policy loses its validity and the User

The services provided to the organization via ULAKNET are stopped.
